

## NEW RULES REGARDING THE AUTHORISATION OF VALUE TICKETS ISSUERS

### LEGAL AND TAX ALERT, 11 April 2019

The authorisation of value tickets issuers is subject to new rules as of April 9, 2019[1].

The new provisions mainly refer to the following aspects:

- *Composition, working procedure and decisions of the Commission for the authorisation of value tickets issuers;*
- *Procedure that must be followed by value tickets issuers in order to obtain the authorisation to operate;*
- *Criteria regarding the authorisation to operate of value tickets issuers, by reference to the types of issued tickets (meal tickets, gift tickets, crèche tickets, holiday vouchers, cultural tickets).*

These new provisions shall apply to all authorisation requests submitted starting with January 1, 2019 by the issuers of meal tickets, gift tickets, crèche tickets and cultural tickets.

In what concerns holiday vouchers, the new regulations shall apply as of January 1, 2021. Until then, the authorisation to operate of holiday vouchers issuers shall remain subject to the provisions of Order No. 2007/2008 of the economy and finances minister[2].
